**2. Action Summary**

Kevin Blanchard went through the changes that were made as a result of the CPCAC May 1<sup>st</sup> meeting and comments after the meeting from members of the CPCAC, staff and the CPTRT.

Discussion:

Flo Meadows suggested that that action item 4.3.7 Add multi-generational so it reads ...”Organize multi-generational “study circles”, “round tables”, or “dialogue forums” to provide residents an opportunity to discuss issues of race, ethnicity and public policy, while building relationships.”The committee agreed.

Kam Movassaghi asked how the UL Master Plan, PlanLafayette and the Horse Farm planning would be intergrated. Kevin Blanchard pointed out that it is already happening and the Better Block Bertrand and future road way improvements move towards making the much needed connection. Jerry Prejean pointed out that at the Central Park board meetings they always being kept up to speed regarding the comp plan.

Alton Trahan requested the opportunity to replace the fire statue picture on pg 11 as the mural had been added to it.

Joby John asked about how interactive the plan would be online after adoption. Kevin said the plan would be a PDF but the action summary would be much more active and accessible.

Kevin reiterated Stephanie Cornay Dugan's concerns regarding the Couir picture at the Horse Farm. Mitzi Moss Duhon made a motion to pull that picture for discussion. Hector LaSala seconded the motion.
