Ms. Candy Leger was the assigned Court Reporter transcribing this hearing. Witnesses were sworn in by Board Attorney Candice Hattan. Ms. Hattan advised all witness of the rules of sequestration. Roll was called Dwight Prudhomme voted no while Christina Olivier, L. Wayne Prejean, Charley Whipp III, and Ron Clark voted yes, Chairman Clark stated "I don't intend for my vote to contribute in having any relevance to any civil actions that may be pending involving either party or whether Ms. Lipps voluntarily participated in the interactions with the appellant, that was not an issue to be decided by the board. We were called upon to determine if the appointing authorities' actions in terminating the appellant was taken in good faith for cause. I find that the action was." Public comment: None

Thus, being done concluding that the board had ruled in favor of upholding Mr. Pratimakone Aphaiyarath's termination.
