(**Time 3:02**) City Finance Chair Kenneth Boudreaux called the budget briefing to order. He then asked Andy Naquin to offer the invocation and Thomas Hooks to lead the Pledge of Allegiance.

Chair Boudreaux welcomed everyone to this budget briefing on the proposed Fiscal Year (FY) 2024-2025 budget. Citizens were instructed that a speaker form should be filled out in order to address the Council and be submitted to Council Clerk Veronica L. Arceneaux. He stated that the proposed budget document has been posted to the LCG website on the Finance page and that public comment would be held immediately following each department's budget review. Chair Boudreaux identified the two (2) possible actions that could be taken during the Wrap-Up briefing. A Council member may propose changing the budget by: (1) a general amendment, when the entire Council agrees on a recommendation/proposed amendment or (2) a separate amendment, when a Council member objects to a recommended budget change.

GENERAL AMENDMENT BY NAQUIN – Reduce line item 9 COURTYARD CIRCLE ALLEY CONSTRUCTION on page 328 from \$15,536 to \$0, reduce line item 54 KALISTE SALOOM RD WIDENING by \$62,241 on page 329, then appropriate the identified \$77,777 to a new capital line item to be created for DULLES DRIVE SIDEWALK & DRAINAGE IMPROVEMENTS

Reflecting on his and Broussard's visit to the LCG warehouse where surplus furniture is stored, Naquin asked that the administration work toward clearing out the space to the greatest extent possible by attempting to meet the needs of the various departments with those items that can be used and by properly disposing of those items that have no future use, especially in the interest of generating space and eliminating costs, liabilities, and hazards. Mayor-President Monique Boulet cautioned that there is a legal archive process whereby many items, even those in disrepair, must be declared as such before being discarded.
