6. DISCUSSION regarding Hazmat Coordinator Qualification Requirements

Board member Wayne Prejean shared insights from his recent meeting with the State Examiner and Deputy. He informed them about the department's challenges regarding the qualifications for the Hazmat Coordinator exam. Mr. Wayne noted his agreement with the State to allow all applicants who applied recently for the Hazmat Coordinator exam to take the exam and then adopt the new class plan at a later time. He confirmed that Fire Chief Benoit approved this approach and provided the board with revised copies of the class plan for review.

Fire Training Chief Gauthier pointed out the changes and differences between the revised class plan and the current version. He noted that the revisions should clarify the language that caused the discrepancies and suggested specifying the requirements for accredited certification. Board members shared their thoughts on the wording of some qualifications, and the discussion continued in order to find solutions. While Training Chief Gauthier agreed with the need for these revisions, he emphasized that the final decision rests with the board.

Interim Hazmat Coordinator Jason Johnson emphasized the importance of requiring additional training, noting that Louisiana currently mandates only 40 hours, whereas most other states require more. He stated that he is actively collaborating with the Chief to enhance training for hazmat positions. Additionally, Mr. Johnson suggested that the language regarding the supervisor's qualifications should mirror that of a Fire Captain.

Board member Charley Whipp III sought insights from Fire Chief Robert Benoit regarding the ongoing discussion. Fire Chief Benoit explained that he has given the board the authority to conduct the necessary research to revise the Hazmat class plan qualification requirements.

Chairman Clark suggested that the Hazmat Coordinator posting notices be tabled until all aspects of the revisions are finalized.

 Board vote to determine if Board will conduct investigation regarding complaint against Major Michael Brown

Confirmation was given to Chairman Clark regarding Mr. Ridge's official petition, which was filed on February 11, 2025. Mr. Ridge emphasized that the board would be best positioned to conduct the investigation related to his complaint against Major Brown.

Chairman Clark informed Mr. Ridge of his rights, including the ability to have witnesses subpoenaed and to present any additional supporting evidence before the next meeting.
