A meeting of the Lafayette Municipal Fire and Police Civil Service Board was held on November 13, 2024 at 9:00 a.m. in the Lafayette Consolidated Government Civil service testing room, 705 West University Avenue, Lafayette, Louisiana. Audio recording of this meeting will become part of the Board's permanent records.

Meeting called to order at 9:10 a.m. and opening statement read by Chairman Ron Clark.

1. Board authorization to approve minutes of October 9, 2024 board meeting

2. Board authorization to approve applications for Police Chief, Police Captain and Hazardous Materials Coordinator

Board members L. Wayne Prejean and Charley Whipp III requested clarity from Fire Chief Benoit regarding the HazMat Coordinator qualification requirements and certifications due to the various certifications received by applicants. Fire Chief Benoit expressed the importance of the right candidate possessing the right certifications rather than just completing course hours. Fire Chief Benoit noted that Hazmat certifications that include a seal with registration numbers are nationally accredited and acknowledged.

Jason Boudreaux stated that he agrees with Fire Chief Benoit but also noted the vagueness of the current Hazmat class plan. He asks that the board consider that some of the applicants who do not hold a sealed certification still possess a strong background in the Hazmat field and should have the opportunity to take the exam. He stressed the importance of staying within the specification of the class plan and that the appointing authority will make the final decision.

Training Chief Gauthier provided additional insight to the Board regarding the nationally acknowledged Hazmat certifications. Chairman Ron inquired if the sealed national Hazmat certification required any extra knowledge to obtain; it was confirmed by Chief Gauthier that it did not but he also noted the high difficulty level of the exam.

Mr. Boudreaux agreed with the comments given by Fire Chief Benoit and Training Chief Gauthier but expressed his concerns regarding the class plan not having a clear definition of which certification(s) are necessary to take the exam. He suggested tabling the motion to approve Hazmat applications till an amended class plan details which Hazmat certification(s) an applicant should have to take the exam. Chairman Clark checked with Chief Benoit to ensure the delay of this appointment does not cause any setbacks to the division while the applications are tabled. Chief Benoit confirmed that he has the necessary amount of people within Hazmat until a new coordinator is appointed.

Motion was made to table Hazardous Materials Coordinator until class plan is defined by L. Wavne Preiean

 Public Hearing: Joshua Bullen vs. Lafayette Consolidated Government (Fire Dept.) Appeal of Suspension "Potential executive session. Parties notified on October 10, 2024"

Firefighter Joshua Bullen represented himself while Lafayette Consolidated Government was represented by Attorney Michael Corry. Ms. Kelley Ackal was the assigned Court Reporter transcribing this hearing. Witnesses were sworn in by Board Attorney Candice Hattan. Ms. Hattan advised all witness of the rules of sequestration. Board member Prudhomme shared his reasons for supporting the suspension due to insubordination, stating that he believes it was carried out in good faith. He expressed that the situation was, to some extent, unnecessary and tragic, stemming from a disagreement over drying of cups. Mr. Prudhomme also remarked that the issue could have been addressed differently.

Board attorney Hattan noted that the record would reflect Attorney Michael Corry's objection to the Board's executive session.

6. General Board business, if any -

Board Secretary Mary Francis reported receiving three public information requests. Ms. Megan Wyatt and Mr. Matt both requested copies of the applications for the Police Chief position. The third request came from Major Brown, who sought a copy of the complaint made against him. Secretary Francis informed the Board about the upcoming relocation of the Police and Fire Civil Service Board office, though the new location was not yet determined. Chairman Ron reassured everyone that LCG is collaborating with the department to ensure a suitable space is secured promptly. Ms. Hattan suggested finding a central location that would be accessible for the respective departments.

7. Report of Counsel or legal updates, if any -

Board attorney Hattan informed the board that she would provide a briefing on the opposition presented by Major Brown before the hearing. She indicated that she would consult with former chairman Jason Boudreaux to locate the transcript and minutes related to the Guy LeBreton complaint. Ms. Hattan recalled that this complaint had been referred to the acting Chief at the time, Reggie Thomas, who was hesitant to make a decision due to political conflicts.

Chairman Clark sought legal counsel from Ms. Hattan regarding the objection raised by Mr. Corry. She stated that when an objection is filed, a basis for it must be presented. Ms. Hattan also mentioned that she had conferred with the State Examiner before the hearing and assured the Board of the current Examiner's reliability.

Board member Cortez asked Ms. Hattan for her counsel on the probability of Board voting outcomes. Ms. Hattan explained that if the vote had resulted in a tie of 2:2, the decision made by the city would stand.
